This letter confirms our understanding of the terms and objectives of our engagement and the nature and limitations of the services we will provide for you in connection with the preparation of the Form 990, return of organization exempt from income tax. We will prepare the return for the year ended December 31, 2022, and subsequent years, from the information you furnish us. This engagement does not include any services not specifically stated in this letter, however, we will be pleased to advise you on income tax matters as to which you specifically request our advice. The Firm is responsible for preparing only the return listed above.

It is your responsibility to maintain the documentation necessary to support the data used in preparing your tax return, including but not limited to the auto, travel, entertainment, gifts, and related expenses. You are also confirming that you will furnish us with all the information required for preparing the return. We will not audit or otherwise verify the data you submit, although we may ask you to clarify some of the information. If you have any questions as to the type of records required, please ask us for advice in that regard. It is also your responsibility to carefully examine and approve your completed tax return before signing and mailing it to the tax authorities.

Our work in connection with the preparation of your income tax return does not include any procedures designed to discover fraud, defalcations, or other irregularities, should any exist. We will render such accounting and bookkeeping assistance as we find necessary for preparing the income tax return.

Please note that the Internal Revenue Service (IRS) considers virtual currency (e.g., Bitcoin) as property for U.S. federal tax purposes. As such, any transactions in, or transactions that use, virtual currency are subject to the same general tax principles that apply to other property transactions. If you had virtual currency activity during the tax year, you may be subject to tax consequences associated with such transactions, and may have additional foreign reporting obligations. You agree to provide us with complete and accurate information regarding any transactions in, or transactions that have used, virtual currency during the applicable tax year. Please ask us for advice if you have any questions regarding the type of records required for virtual currency transactions.

It is our firm's policy to electronically file all exempt organization returns. Although e-filing requires both you and our firm to complete additional steps, the same filing deadlines will apply. You must therefore ensure that you complete the additional requirements well before the due dates in order for our firm to be able to timely transmit your return. We will provide

you with a paper copy of the income tax return for your review prior to electronic transmission. After you have reviewed the return, you must provide us with a signed authorization indicating that you have reviewed the return and that, to the best of your knowledge, you believe it is correct. We cannot transmit the return to the taxing authorities until we have the signed authorization. Therefore, if you have not provided our firm with your signed authorization at least three days prior to its due date, we will attempt to contact you. Should we be unable to contact you, we will place your return on extension, even though it might already have been completed. In that event, you will be responsible for ensuring that any payment due with the extension is timely sent to the appropriate taxing authorities. You will also be responsible for any additional costs our firm incurs arising from the extension preparation.

If an Extension of Time To File is requested, any tax that may be due with this return must be paid with the extension. If any amounts are not paid by the filing deadline, you will be subject to interest and late payment penalties when these amounts are actually paid.

We will use our professional judgment in preparing your returns. Whenever we are aware that a possibly applicable tax law is unclear or that there are conflicting interpretations of the law by authorities (e.g., tax agencies and courts), we will share our knowledge and understanding of the possible positions that may be taken on your return. In accordance with our professional standards, we will follow whatever position you request, as long as it is consistent with the codes, regulations, and interpretations that have been promulgated.

If a taxing authority should later contest the position taken, there may be an assessment of additional tax, interest, and penalties. We assume no liability for any such assessment of additional tax, penalties, or interest. In the event, however, that you ask us to take a tax position that in our professional judgment will not meet the applicable laws and standards as promulgated, we reserve the right to stop work and shall not be liable for any damages that occur as a result of ceasing to render services.

It is our policy to keep records related to this engagement for seven years. However, the Firm does not keep any original client records, so we will return those to you at the completion of the services rendered under this engagement. It is your responsibility to retain and protect your records (which includes any work product we provide to you, as well as any records that we return) for possible future use, including potential examination by any government or regulatory agencies. 
